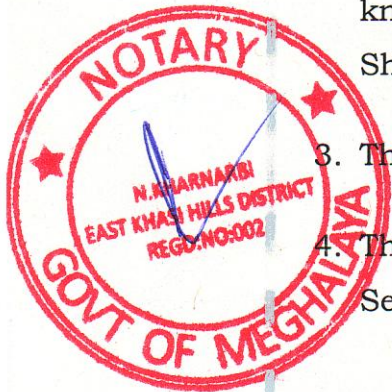
**AFFIDAVIT**

4. That the college initially functioned from Jail Road Boys' Higher Secondary School till 1972 as it did not have its own building.

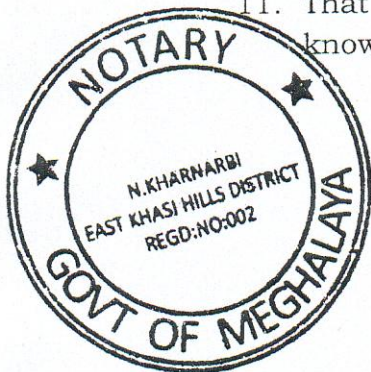

5. That the College constructed its own Building at the current location.
6. That the Building Plan and Building Completion Certificate or any other connection document which dates back to about 48 years cannot be traced in College and all efforts to locate the same failed.
7. That the Contractor of the said Building Mr. K.M. Diengdoh passed away many years back.
8. That, no document relating to the Approved Building Plan of the year 1970 and the Building Completion certificate of the year 1972 by the Competent Authority could also be found from his heirs.
9. That the College of Teacher Education (PGT) and its building already existed prior to NCTE recognition. That on the 11<sup>th</sup> February 1997 the College was recognized by the National Council of Teacher Education.
10. That this affidavit is sworn in for the purpose of declaring that the College of Teacher Education (PGT) erstwhile known as (PGT) College constructed its own building and started functioning from the current location from the year 1972 and that the Building Plan and Building Completion Certificate if any which dates back to about 48 years could not be traced in the College nor could it be obtained from the concerned competent Authority or the legal heirs of the Contractor and for all other intents and purposes.
