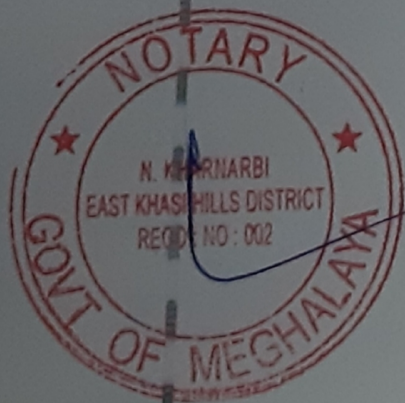
**AFFIDAVIT**



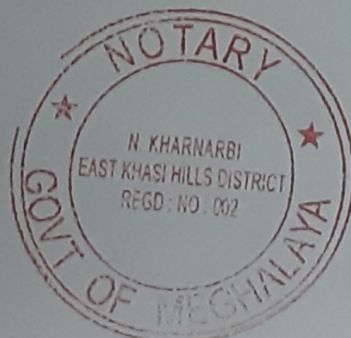
